I have developed a compendium of indicators to be used for monitoring progress by 160 UNICEF country offices toward the World Fit for Children goals; consulted on methodology for developing cross-national indicators of parent-adolescent connection and regulation for WHO; coordinated the selection of indicators of contextual factors for inclusion in the second edition of *Guide to Monitoring and Evaluation of HIV/AIDS Programmes for Young People*; recommended indicators of protective factors to be included in the Global School-based Student Health Survey (currently being used in 84 countries); and consulted on the methodology for a cross-national comparison of risk and protective factors for adolescent health and provided analyses of US and Caribbean data.
